Interpreting content area results:

- Content area results are provided to help evaluate your school's curriculum and identify areas of strength and weakness. The equated percent correct (EPC) scores on the previous page are based on the performance of first-time takers from your school on each major content area for this examination.
- Average content area EPC scores are also shown for the comparison group: first-time takers from LCME-accredited medical schools who took a form of this examination as an end-of-course or end-of-clerkship examination, under standard timing conditions, between 08/01/2021 and 07/31/2022.
- Keep in mind that individual content areas may be easier or more difficult than the overall content domain represented by total EPC scores, and are measured less precisely. For that reason, the average total EPC score for your school may be lower or higher than several of your school's average content area EPC scores.
- Additionally, small differences between average EPC scores for your school and the comparison group should not be
 overinterpreted because some content areas are based on a relatively small number of items. Asterisks are used to highlight
 smaller (*) and larger (**) differences in average EPC scores that are statistically meaningful based on an effect size approach
 that uses unrounded averages and standard deviations.
