## NBME Self-Assessment Bundling Promotion Commonly Asked Questions

In response to feedback from medical students, NBME is pleased to offer a discounted rate on the purchase of 3 NBME Self-Assessments. During an 8-week promotional period, examinees will be able to:

- Save \$20 on a bundle of 3 Comprehensive Basic Science Self-Assessment (CBSSA) forms May 13-July 15, 2024\*
- Save \$20 on a bundle of 3 Comprehensive Clinical Science Self-Assessment (CCSSA) forms May 13-July 15, 2024\*

*\*The discounted savings will increase to \$26 per bundle after July 1, 2024.*

### ***When will the NBME Self-Assessments I purchased expire?***

**You will have 1 year from date of purchase to launch and complete all self-assessments.** The expiration date cannot be extended beyond 1 year from date of purchase.

### ***Does a bundle need to be spent in a single product line for comprehensive self-assessments? For example, can a bundle of 3 self-assessments be used to purchase 2 CCSSAs and 1 CBSSA?***

For the comprehensive self-assessments, the bundled discount must be used for 3 CBSSAs or 3 CCSSAs. A discount will not be applied across different comprehensive assessment product lines.

### ***Can I still purchase a single self-assessment?***

Yes, examinees will still be able to purchase single self-assessments at regular cost.

### ***Can I receive a discount for Comprehensive Clinical Medicine Self-Assessment (CCMSA) or IFOM® Self-Assessments?***

CCMSA and IFOM Self-Assessments cannot be bundled and are sold at regular cost.

### ***Do I need to select specific exam forms when I purchase a bundle of NBME Self-Assessments?***

No, you don't need to select exam forms when you purchase a bundle. You will need to select a specific exam form when you launch it.

### ***Can I purchase multiple NBME Self-Assessment bundles in the same order?***

You may purchase as many discounted bundles as you like. However, if you wish to purchase multiple of **the same bundle**, i.e. 2 CBSSA bundles, *you cannot do so in the same order*. You will need to complete a separate order to purchase multiple bundles for the same exam family (2 or more bundles of CBSSA or 2 or more bundles of CCSSA).

You can still purchase multiple bundles in the same order across the bundled products. For example, a bundle of CBSSA and a bundle of CCSSA can be purchased in the same order.

***Will a discount be provided for purchases of an additional form outside the bundle of 3? For example, I want to purchase 4 or 5 CBSSA forms.***

You will receive a discount for the bundle of 3, but you will need to pay full price for the fourth and fifth assessments purchased. You will receive a discount when you purchase 6 self-assessments (i.e., two bundles of 3), but you will need to place 2 separate orders and the bundles of 3 will need to be all CBSSA or all CCSSA.

***Can I use a voucher as partial payment toward the purchase of a bundle?***

No, the vouchers are redeemable for discrete single self-assessment purchases rather than a dollar value, so they cannot be used as partial payment toward the purchase of a bundle.

***Can I change my form selection and pacing for unlaunched assessments in the bundled purchase?***

Yes, the form number and pacing can be changed on assessments purchased as part of the bundling promotion if the assessment is not launched.

***I purchased a bundle of 3 self-assessments, but I did not start or use any of the assessments in the bundle. Can I receive a refund?***

If none of the bundled self-assessments were launched, a refund may be issued.

***I purchased a bundle of 3 and used 1 or 2 of the self-assessments. Can I receive a refund on the unused portion?***

No, we cannot issue refunds for the purchase of bundled self-assessments *after* an assessment has been launched. Refunds can only be offered in the case none of the bundled self-assessments have been launched.

***I already purchased 3 CBSSA or 3 CCSSA forms prior to the discounted promotion. Can I receive a discount/refund the difference of the discounted price?***

Unfortunately, we cannot retroactively apply discounts on purchases made prior to the bundling promotion.
